

RULES FOR THE COMPETITIONS:

❖ RESEARCH POSTER COMPETITION-

1. Participants can prepare research poster on any socio-legal issue.
2. Research Poster shall be in 'Digital form' only.
3. Participants shall observe rules of research methodology while preparing poster.
4. Each team will get 15 minutes for presentation of their poster(12+3)
5. In support of Research Poster participants need to submit research paper (not more than 1500 words).

❖ DRAFTSMAN COMPETITION-

1. Topic to draft bill: "Live- in Relationship"
2. Participants shall follow rules of drafting a statute.
3. Bill shall be comprised of not more than 15 sections
4. Draft Bill shall consist of- short and long title, object and reasons, Preliminary provisions, Main Body of statute and miscellaneous provisions.
5. Each team will get 20 minutes for presentation and justification.
6. Draft must be prepared in English language only.
7. The bill should be typed on A4-sized paper.
8. The font used must be Times New Roman, size 12, double line spacing, and One-inch margin on each side.
9. The font of footnotes must be Times New Roman, Size 10, single line spacing. Page numbers must be given at the Top Right hand corner.

❖ COMMON RULES:

1. All UG students can participate in competition. (Three Year Law and Five Year Law Course)
2. Each team shall be comprised of two participants.
3. Participants must carry college Identity cards
4. Registration fee - 500 Rs for each competition
5. One team can participate in both competitions
6. Content in research poster and draft must be original and acknowledged
7. Organizers have reserved all rights regarding competitions. Any required change can be made subject to previous intimation.
8. Selected 5 entries will be invited for the presentation and justification of work.
