Report

As per the pre-set modus operandi of the Internal Complaint Cell (ICC), the meeting of the members was conducted on the beginning of the new academic term. The security measures of the Campus are reviewed to ensure the safety and security. As the Discipline Committee, CCTV surveillance, ragging prevention cell and Patrolling of Police Department's Nirbhya Patha on the regular basis safeguard the campus from sexual harassment, violence, ragging and any other form of torture. Most of the problems and issues were solved on the personal level by the Principal and member-teachers of the ICC. The serious problems of annoyance, rarely appeared in the last five years, but whenever it appears the ICC solved it by adopting the rigorous measures prescribed by the UGC. Though, the issues of harassment and serious kind of assaults are not observed in many subsequent years, the ICC has developed a well-defined modus operandi to solve such kind of cases. Initially, the charged student has to face the committee of ICC for interrogation; the parents meeting will be arranged with Principal and members of ICC; if it turn to be a very serious case which can be held punishable as per the provisions of law, the police department will be called in for further investigation and FIR registration. The counselling, moral support and re-habitation will be undertaken. The ICC will investigate the case by establishing a separate committee consisting the advocates and members of ICC.
